FARM: The Guidelines and Manual for the Farm was revised which led to a number of changes.

CELLAR: The Guidelines and Manual for the Cellar did undergo some small revisions (2010). **More information will also be made available regarding the workings of the electronic IPW database and how this affects producers at farm and cellar level.**

Those who attended a training course before 2008 or who have not attended a course yet, are strongly advised to attend a course this year. A training certificate will be issued to the persons that attend the courses, be it only on the Farm Guidelines (morning session), only on the Cellar Guidelines (afternoon session) or both (whole day).
